All bidders who participate in the live U.S. Treasury auction via simulcast bidding are responsible to read and comply with the Sale Terms and agree to be bound thereby. AECOM nor CWS accepts responsibility for loss of connectivity, technical difficulties or other circumstances beyond our control.

The submission of this form authorizes AECOM or its agents to process the named bidder's credit card in the amount of \$10,000, or the final bid price (plus any applicable sales tax), whichever is less, upon the successful bid at auction. Successful bidders must pay for and remove all purchases according to the Sale Terms.

### **Steps To Bid:**

1. Completely fill out this Simulcast Bidding Credit Card Authorization form and email or fax to [service@cwsmarketing.com](mailto:service@cwsmarketing.com) or 571-393-3388. **ALL BID DEPOSIT FORMS MUST BE SUBMITTED BY 3:00PM THE DAY PRIOR TO THE SALE TO QUALIFY.** All three (3) pages must be initialed, and the Authorization page signed in order to qualify to bid. The bidder's credit card will only be charged if successful.
2. Upon receipt and approval of the form, an email notice will be sent with bidding instructions.
3. Attend the established preview for the auction items. Preview information is found in the catalog or online at the [cwsmarketing.com](http://cwsmarketing.com) website. All bidders are urged to inspect the property prior to bidding.
4. Once approved, click on the simulcast bidding link for the specific auction at [cwsmarketing.com](http://cwsmarketing.com), log in and bid during the designated times.
5. If successful, your initial bid deposit will be paid via the credit card information submitted. Final payment instructions, along with an invoice showing the balance due, will be emailed to you. Final payment may be made with credit card, bank wire or by cash at the local sale center, and must be made according to the Terms of Sale. There is no extension for Final payment.
6. An Auction Receipt and property Release Document will be emailed to you upon final payment. Once received, the Buyer is to remove property according to the Sale Terms.

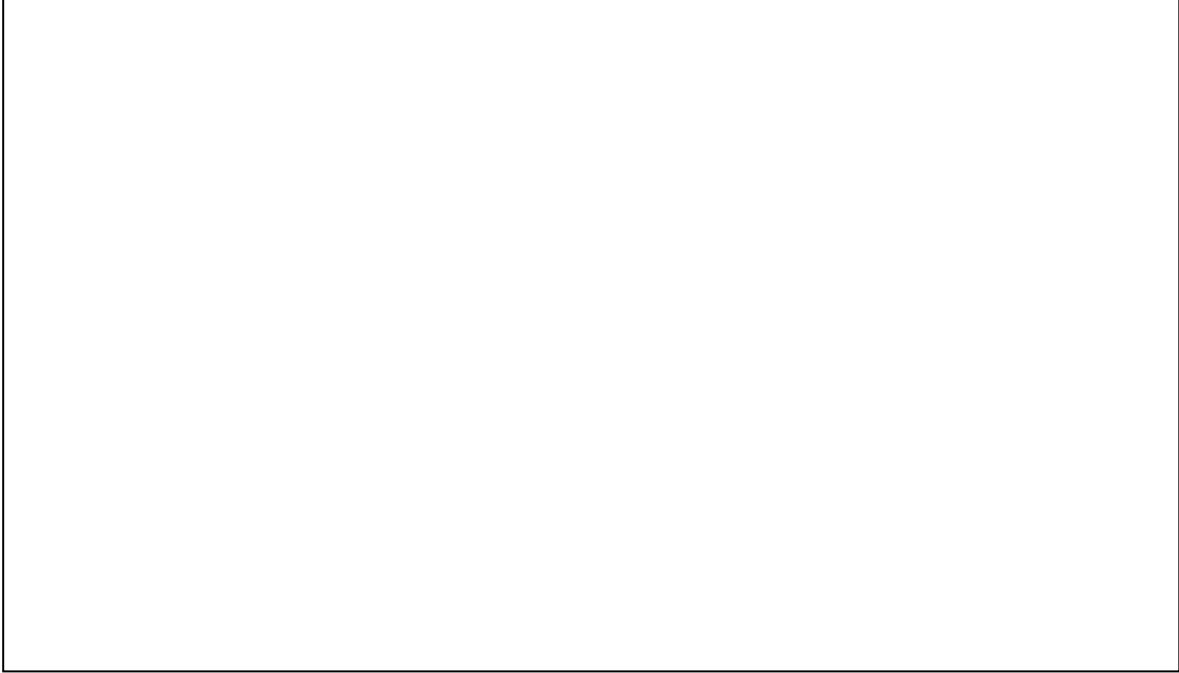
