



GRAPHIC DESCRIPTION: 1. INTERIOR/EXTERIOR DIVIDING WALL WIDTHS 2. SUBJECT TO ALL EASEMENTS SET FORTH IN THE DECLARATION OF CONDOMINIUM AND ALL OTHER MATTERS OF RECORD.

3. THE CONDOMINIUM HAS BEEN ESTABLISHED IN SUCH A MANNER AS TO MINIMIZE THE COMMON ELEMENTS. MOST COMPONENTS THAT ARE TYPICAL "COMMON ELEMENTS" OF A CONDOMINIUM HAVE INSTEAD BEEN DESIGNATED HEREIN AS PART OF THE SHARED COMPONENTS OF THE SHARED FACILITIES UNIT. FLOOR SLABS ARE NOT DEPICTED HEREON BUT ARE CONTAINED WITHIN THE SHARED FACILITIES UNIT.
