CWS Marketing Group (CWS) received a letter dated October 28, 2021, regarding a driveway extension and was asked to submit an architectural application for approval. CWS, USA and HSI have no knowledge of when this work was completed, contractor, plans or any information regarding the driveway extension.

The application was submitted as a formality at the request of Seacrest Services, the property management company for Black Diamond HOA. The application was denied.

On December 8, CWS received information regarding the violation. The driveway is extended past the frame of the house on the right side. Please see attached illustrations.

CWS will not be completing the removal of the driveway extension. The buyer will be responsible for remedying the violation with the HOA Architectural Control Committee after closing.
